



Comparison of Nonprofit Provisions in NC House and NC Senate Budget Proposals for FY2021-2023

Revised: December 1, 2021

Differences between the Senate and House budget are highlighted. Items in green indicate better provisions for nonprofits, and items in red indicate problematic provisions for nonprofits. Appropriations to individual nonprofits are generally not marked in green.
