Q1. Please tell us about your personal experiences with nonprofits. How do these experiences shape your policy positions? (Limit: 300 words)

I was raised to give back to my community whenever and wherever I could. We volunteered at our downtown church, worked with another church to help Montagnard refugees from Vietnam to get resettled, built homes with Habitat for Humanity, and attended YMCA after-school care for years. Since moving to Asheville, I have worked with countless nonprofits in my role as public school teacher and former co-leader of our school's Community Outreach Committee. We held "community nights" where we invited local nonprofits to the high school so parents and families could learn more about what resources and services where available to them. This included the YMCA, Manna Food Bank, Eblen Charities, United Way, Eliada Homes, etc. Since leaving the classroom, I have used my position on various local Democratic party auxiliary boards to connect with local nonprofits and collaborate on projects. As adult advisor of the local teen Democrats, we put together care packages for BeLOVEd Asheville, volunteered for Manna Food Bank, and participated in roadside clean-up with Asheville GreenWorks. I believe strongly in not reinventing the wheel or duplicating efforts, so I've worked hard to highlight the good work that's already being done in our communities.

Q2. If elected, what would be your top three policy priorities? (Limit: 250 words)

The first would be stronger funding for our public schools and our teacher-preparation programs. North Carolina used to be a model in the South for our K-12 public education system, and I believe we can be again. Second would be expansion of healthcare access, particularly in rural areas. Medicaid needs to be expanded yesterday, and we need more robust mental health services as well. Finally, I'll be fighting for good government policies like independent redistricting and expanded access to the ballot.
