Q1. Please tell us about your personal experiences with nonprofits. I started my very first post-college job at a non-profit, Child Care Services Association, in Chapel Hill. Outside of a three year span I taught public school, my entire career, over twenty years, has been working for non-profits in the triangle area. These include: Durham Crisis Response Center, Interfaith Council/Project Homestart, WakeEd Partnership, NCPTA, and a global public health organization. Q2. If elected, what would be your top three policy priorities? (Limit: 250 words)

Affordable housing is a complicated but critical issue. There are many definitions of affordable housing and many different ideas about how to ensure it, but as county commissioner, I'm most interested in building consensus. We have all seen housing costs increasing dramatically, and we know that it has disproportionately impacted low income and fixed income residents, particularly in our communities of color. I want to work with these communities and other groups who are priced out of housing in our area, such as public servants, and our municipalities to develop solutions that work for everyone. I believe public-private partnerships are a part of that. I believe innovation is a part of that. And I believe strong social services are a part of that.

The service provided to our country by our military members should not be ignored. Funding and establishing a Veteran's court to address the specific needs of those who served our country and better supporting our large Veteran population that resides in Wake County would be one of my objectives.

As the daughter of a retired educator, a parent, a former teacher, graduate of public schools, and a current WCPSS substitute, I know first-hand that a robust public education system is the foundation of our community. One of my priorities would be to expand early childhood educational opportunities by working with local agencies to ensure needs are met for all families. Additionally, we need to hold our state elected officials accountable to fully fund our public schools, so that we can maintain quality teachers and staff.
