Q2. If elected, what would be your top three policy priorities? (Limit: 250 words)

My top 3 policy priorities for nonprofits going into next Session:

- 1. Legislation to ensure that state agencies (a) avoid delays in paying nonprofits that deliver services; and (b) inform them in advance if a payment will be late, as well as supporting polices that address systemic problems with nonprofit-government contracting, including late contracting, late payments, and underpayment for indirect costs.
- 2. I would also support legislation to protect nonprofit independence, opposing policies that limit nonprofits' governance as independent, nongovernmental corporations with control over their own organizational policies and practices.
- 3. I will support incentives for charitable giving, such as universal, non-itemizer tax deductions or credits for charitable contributions that incentivize all North Carolinians to give generously to the work of charitable nonprofits. I would oppose limits on the charitable deduction on state income taxes.

The Center advocates on public policy issues that affect North Carolina's nonprofit sector and works with the NC General Assembly and North Carolina's members of Congress to develop laws and policies that save nonprofits time and money, help nonprofits operate more effectively, and preserve the public's trust in North Carolina's nonprofit sector. Our policy agenda includes: Ensuring that all 501(c)(3) nonprofits are fully exempt from federal, state, and local taxes. Promoting new and expanded tax deductions and credits that encourage individuals and businesses to give generously to support their communities through the work of charitable nonprofits. Supporting policy solutions that will address the nonprofit workforce shortage, including increased funding to support jobs in the nonprofit sector and investment in accessible and affordable child care. Seeking solutions to long-standing challenges that nonprofits face when they provide public services through government grants and contracts, including late contracts, late payments, overly complicated application and reporting requirements, and underpayment for indirect costs. Promoting laws that will help nonprofits and businesses alike to provide affordable and high-quality health care and other benefits to their employees.Q3.
